WATER SOURCES: The Texas Commission on Environmental Quality has assessed Harris County Municipal Utility District No. 150's water and has determined that it is safe to drink. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. Harris County MUD No. 150's water sources include both groundwater and surface water sources. The District owns and maintains water wells which have the ability to pump groundwater for the District. The wells obtain water from the Gulf Coast Aquifer. The District additionally purchases surface water from Central Harris County Regional Water Authority which pumps such water from Lake Houston. For the year 2024, the District received water from the Central Harris County Regional Water Authority. No groundwater was used from its water wells. The District maintains its water wells to provide a backup source of water in the event that the surface water supply from the Central Harris County Regional Water Authority is compromised or is otherwise unavailable. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals, and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Contaminants that may be present in source water include:

UCMR5

The Fifth Unregulated Contaminant Monitoring Rule (UCMR 5) was published on December 27, 2021. UCMR 5 requires sample collection for 30 chemical contaminants between 2023 and 2025. The data collected under UCMR 5 improves understanding of the prevalence and amount of 29 per- and polyfluoroalkyl substances (PFAS) and lithium in the nation's drinking water systems.

UCMR5

The Fifth Unregulated Contaminant Monitoring Rule (UCMR 5) was published on December 27, 2021. UCMR 5 requires sample collection for 30 chemical contaminants between 2023 and 2025. The data collected under UCMR 5 improves understanding of the prevalence and amount of 29 per- and polyfluoroalkyl substances (PFAS) and lithium in the nation's drinking water systems.

Unregulated contaminants are those for which the EPA has not established drinking water standards. The purpose of unregulated contaminant monitoring is to assist the EPA in determining the occurrence of unregulated contaminants in drinking water and whether future regulation is warranted. Any unregulated contaminants detected are reported in the following table.
